The Department of Pathology at the University of New Mexico, Health Sciences Center School of Medicine is seeking a **neuropathologist**. Academic rank and tenure track will be determined based on qualifications and experience. Service responsibilities will consist of surgical and autopsy neuropathology in an academic tertiary care center with a growing regional outside neuropathology and muscle pathology consult service. There is an option of a role in general surgical pathology. The successful candidate will hold an academic appointment in the Department of Pathology and with joint appointments in the Departments of Neurosurgery and Neurology. The neuropathologist will participate in diagnostic, teaching, and translational research activities. Located at the University is the UNM Cancer Center an NCI-designated cancer center and newly NIH-funded Clinical and Translational Science Center. An active neurosciences community includes the UNM Biomedical Research and Integrative Neuroscience (BRaIN) Center, the Mind Research Network, and the developing Brain and Behavioral Institute. The University of New Mexico is a sponsor of TriCore Reference Laboratories which provide comprehensive anatomic and clinical pathology services (<http://www.tricore.org/>).

Minimum Requirements: 1) board certification or board eligibility in Anatomic Pathology; 2) subspecialty fellowship training in neuropathology; 3) MD or equivalent; and 4) eligible to work in the United States.

Desirable qualifications: 1) outstanding neuropathology clinical skills; 2) experience in training pathology residents in surgical and autopsy neuropathology; 3) experience teaching neuropathology in an undergraduate medical curriculum; 4) experience and publication record in neurosciences translational or clinical research.

Rank and salary will be commensurate with experience and education. For best consideration, applications must be received by June 30, 2011; however, the position will remain open until filled. The cover letter must address each qualification and how it relates to the position and, the names, addresses, and telephone numbers of three references. Candidates will be consulted before references are contacted. This position may be subject to criminal records screening in accordance with New Mexico law. If criminal records screening is mandated, clearance by the New Mexico Department of Health is required as a condition of employment.
